(ACT NO. 35 OF 1984)****CONTROL MEASURES RELATING TO FOOT AND MOUTH DISEASE IN CERTAIN AREAS**

The Minister of Agriculture, Land Reform and Rural Development acting under Section 9 (1) of the Animal Diseases Act, 1984 (Act No. 35 of 1984) hereby-

- (a) repeal the control measures relating to foot and mouth disease in certain areas as prescribed in Government Notice No R. 76 of 1 February 2019, No. R. 569 of 30 June 2021 and No. R. 827 of 7 September 2021; and
- (b) prescribe the control measures set out in the Schedule hereto.

**SCHEDULE****1. Definitions**

In this Schedule any word or phrase to which a meaning has been assigned in the Act, shall have that meaning and, unless the context otherwise indicates-

“foot and mouth disease” means the disease as specified in column 1 of Table 2 of the Regulations and as described in column 2 of Table 2 of the Regulations opposite thereto;

“the Act”, means the Animal Diseases Act, 1984 (Act No. 35 of 1984)

“the Regulations”, means the Animal Diseases Regulations as published by Government Notice No. R. 2026 of 26 September 1986, as amended by Government Notices Nos. R. 2208 of 24 October 1986, R. 266 of 13 February 1987, R. 2343 of 16 October 1987, R. 884 of 5 May 1988 (as corrected by Government Notice No. R. 1043 of 3 June 1988), R. 394 of 1 March 1991 (as corrected by Government Notice No. R. 931 of 3 May 1991), R. 2358 of 10 December 1993, R. 1023 of 27 May 1994, R. 254 of 6 February 1997, R. 1136 of 11 September 1998, R. 361 of 7 April 2000, R. 443 of 25 May 2001, R. 885 of 21 September 2001 (as corrected by Government Notice No. R. 1386 of 21 December 2001), R. 162 of 24 February 2006, R. 163 of 24 February 2006, R. 864 of 1 September 2006 (as corrected by Government Notice No. R. 1059 of 27 October 2006), R. 204 of 16 March 2007, R. 371 of 26 April 2007, R. 543 of 6 July 2007, R. 527 of 15 May 2009, R.558 of 22 May 2009, R. 1059 of 13 November 2009, R. 564 of 23 June 2010, R865 of 7 November 2014.

**2. Objective of control measure**

The objective of this control measure is, in order to prevent the spreading of foot and mouth disease from the Kwa Zulu Natal Disease Management Area (KZN DMA) and Limpopo Disease Management Area (Lim DMA) to prohibit the movement of animals, animal products and genetic material except on authority of a permit to, from or within such areas.

**3. Prohibition on the movement of animals, animal products and genetic material except on authority of a permit**

- (1) No cloven-hoofed animals, animal products derived from cloven-hoofed animals or genetic material of cloven-hoofed animals may be moved from, to or within the KZN DMA and Lim DMA, except under the authority of a permit contemplated in Regulation 20 (1) of the Regulations
- (2) All cloven-hoofed animals must be inspected by a state veterinarian before the permit referred to in sub-clause (1) may be issued in respect thereof.

**THE KWA ZULU NATAL DISEASE MANAGEMENT AREA**

The following are declared to be part of the Kwa Zulu Natal Disease Management Area:

- (i) The whole of the Umkhanyakude District Municipality, consisting of Jozini Local Municipality, Umhlabuyalingana Local Municipality, Big Five Hlabisa Local Municipality and Mtubatuba Local Municipality;
- (ii) The whole of the King Cetshwayo District Municipality, consisting of uMfolozi Local Municipality, City of uMhlathuze Local Municipality, uMlalazi Local Municipality, Nkandla Local Municipality and Mthonjaneni Local Municipality;
- (iii) The whole of Hluhluwe Imfolozi Park;
- (iv) The whole of Nongoma Local Municipality in the Zululand District Municipality;
- (v) The whole of the Ulundi Local Municipality in the Zululand District Municipality;
- (vi) The portion of the Pongola Local Municipality in the Zululand District Municipality that lies to the east of the R66, and south and west of the N2 and the portion that lies to the east of the N2, south of the road P522 leading to Jozini;
- (vii) The portion of the Maphumulo Local Municipality in the Ilembe District Municipality that lies to the east of the R74;
- (viii) The portion of the Ndwedwe Local Municipality in the Ilembe District Municipality that lies to the east of the R74 and to the north of the road P110;
- (ix) The portion of the KwaDukuza Local Municipality in the Ilembe District Municipality that lies to the north of the road P110;
- (x) The portion of the Mandeni Local Municipality in the Ilembe District Municipality that lies to the north of the road P110 on the east of the R102 and north of the Tugela River on the west of the R 102;
- (xi) The portion of the Umvoti Local Municipality in the Umzinyathi District Municipality that lies to the east and north of the R74 and to the east of the R33; and
- (xii) The portion of the Msinga Local Municipality in the Umzinyathi District Municipality that lies to the east of the R33, south of the Tugela River.

**THE LIMPOPO DISEASE MANAGEMENT AREA**

The following are declared to be part of the Limpopo Disease Management Area:

- (i) The whole of Collins Chabane local municipality;
- (ii) The whole of Thulamela local municipality;
- (iii) The portion of Greater Giyani local municipality, Greater Letaba local municipality and Molemole local municipality which lies north of the R36 road from the N1 Highway to Mooketsi. Along the Mooketsi / Giyani Road (R81) from Mooketsi to where the road crosses Little Letaba River up to the fence on the KNP;
- (iv) The portions of Makhado local municipality and Musina local municipality which lies east of the N1 Highway from where the R36 road crosses the N1 Highway, including the Musina Nature reserve, following the border of the Musina Nature reserve until where it crosses the Venetia Mine Road, following the Venetia Mine Road until the R521, following the R521 until the international boundary at Pont Drift Border Post; and
- (v) The northern boundary is the international border between Pont Drift Border Post and the Kruger National Park fence, while the eastern boundary is the Kruger National Park fence.
